The Borough of Berlin wanted to take ownership of Blase's property. Before they could do so, an environmental study needed to be completed to determine if the property had contamination.

Pennoni had completed Phase II and the Borough was ready to move forward. In order to receive grant money, the Borough must own the property. The project has come to a halt. Not because of the county, council, or the state, but because of Tlyer vs Hennepin County that the Supreme Court is handling. Things have now been put on hold. The Borough is not the only municipality this is affecting as this is a statewide issue.
