**BUILDINGS, PARKS, & RECREATION** Councilman Badolato and Councilman Mascarenhas

Councilman Badolato met with the Police Department this past week and they decided on a type of fence that would work well with the department. Councilman Badolato is still waiting for the estimate to get the cameras hooked up at the community center, and the wiring from the electrician. Councilman Badolato had a meeting with Councilman Mascarenas and Council President Miller, regarding the playgrounds and Councilman Mascarenhas will go more in detail because he's done a lot of leg work and states that he has done a really good job with it. Councilman Badolato would like to thank him for that. He also would like to thank his granddaughter Amelia ,because if it wasn't for her, he might not have gone to the playground.

Councilman Mascarenhas hands out packets to Mayor and Council on designs for all 3 Berlin Parks. States that his granddaughter was his inspiration for all this.

Councilman Mascarenhas says the plan is to start one park at a time until that park is completed then move on to the next park.

He states this will be done through State Contract and the ballpark totals are about \$100,000 per park.

Mr. Long compliments Councilman Mascarenhas on a job well done.

#### PUBLIC WORKS, STREETS & ROADS - Councilman Wilkinson and Councilman Cummings

Councilman Wilkinson states that he was advised from Public Works that the Organics Collection is now back to the regular schedule and pick up regularly scheduled days on trash days.

Spring leaf collection begins Monday, April 1st and will end April 12th.

There was 42.5 tons of single steam recycling collected the last month 282 tons of trash was collected for the month of February, £90 of electric waste was collected for the month of February 3 tons of cardboard was collected for the month of February.

The Berlin Borough 2024 road project will include Hillcroft, Independence Court , Evanine Drive and Princeton Court.

The Haddon Avenue Bridge is currently being worked on. Estimated time that the bridge will remain closed is Memorial Day.

There is no estimated time when the Crosskeys road project will get into Berlin.

> WATER & SEWER - Councilwoman Cummings and Councilman Badolato

Councilwoman Cummings was absent.

Councilman Badolato had nothing to report.

> **PUBLIC SAFETY** – Councilman Hohing and Councilman Mascarenhas

Councilman Hohing states monthly numbers, EMS typical volumes. Berlin Borough did 106 calls which is about 45% overall. The volume Berlin Township did was 71 calls altogether and about 30% and the residual 10 or 12% was surrounding neighborhoods as well.

Berlin Fire company responded to 57 calls for service in the month of February and reported dwelling fires to rescue assignments and five motor vehicle accidents. They had one vehicle, fire, one wires down, and 14 alarm systems and six natural gas calls.

The Borough firefighters receive training on Tuesday nights. That included firefighter safety and EMS review electric vehicle and anatomy and hazards, fire scene preservation and the Solid Rock walk through. They also staffed weekly daytime duty crews and during those hours ready to respond to all calls for service, review and inspect the checked apparatus hall, maintenance, cleaning, and extra training. Councilman Hohing states day duty crews did come in handy in several instances this past month.

Councilman Hohing wants to point out that the Berlin Fire Company is proud to announce that they were awarded the American Rescue Plan Firefighters Grant for 2024 in the amount of \$75,000.

Police department report is as follows. They had 2724 calls for service as compared to 2629 in January, slightly up 312 summonses as compared to 231 in January, that's significantly increased. They had 25 arrests compared to 33 in January. 29 motor vehicle crashes compared to 41 in January and 278 traffic stops compared to 130 in January.

# YOUTH ATHLETICS AND COMMUNITY EVENTS- Council President Miller and Councilman Wilkinson

Councilman Wilkinson has submitted some things he needs approval on from the CFO, to find out what can be budget for those programs specifically the soccer and the baseball.

Councilman Wilkinson thanks Andy Simone for his help working on the batting cages.
