### BUILDINGS, PARKS, & RECREATION

Councilman Badolato reports on negotiations with New Jersey Transit regarding a guardrail at the train station and ongoing issues with street light repairs. The council discusses the need to resurface the community center parking lot and potential bidding process for the project. Updates are provided on fire department and police department activities, including call statistics and officer recognition.

Councilman Mascarenhas emphasizes the need to reinvest in youth athletics facilities, including field maintenance and lighting improvements. The council discusses potential costs for field upgrades, with lighting projects estimated at around \$800,000. There is consideration of taking over field maintenance from the school district and allocating an annual budget for ongoing upkeep.

The council introduces the 2025 municipal budget for Berlin Borough, with a public hearing scheduled for April 10, 2025. Multiple resolutions are passed, including those authorizing local examination of the budget and approving various administrative matters.
