Utility Department Update — Councilwoman Cummings

Councilwoman Cummings provided the following report regarding Utility Department operations:

- **Account Adjustments & Equipment Upgrades**
 - Approximately 130 utility accounts remain to be adjusted.
 - Equipment upgrades are still pending due to a modem issue awaiting resolution with Verizon, which will enable full system functionality once complete.

- **Service Orders and Maintenance**
 - 11 service orders completed for water meter repairs and replacements.
 - 89 utility markouts performed across the Borough.
 - Monthly maintenance was successfully conducted on both water plants, including work on 10 meters.

- **Water System Activities**
 - Town-wide fire hydrant flushing was completed.
 - The next scheduled flushing is set for October.

- **Sewer System Operations**
 - Routine monthly maintenance completed on all 10 pump stations.
 - Monthly generator maintenance also conducted without issue.
 - A temporary malfunction at the Cross Keys Pump Station occurred due to out-of-calibration level floats; the floats were recalibrated, and the system has returned to normal operation.

- **Franklin Avenue Sewer Project**
 - Preliminary work continues. A tentative schedule is being developed and will be provided in future update once finalized.

Police Department Report — Councilman Hohing

- For the month of **May**, the Police Department responded to a total of **2,845 calls for service**, slightly decreased from **2,802** in April, demonstrating consistent activity.
- **Traffic Enforcement:**
 - **Summonses Issued:** 336 (up from 238 in April)
 - **Arrests:** 17 (down from 40 in April)
 - **Motor Vehicle Crashes:** 45 (up from 29)
 - **Traffic Stops:** 294 (up from 160)

Directed Patrols

- **Jackson Road:** Focused enforcement for speeding and stop sign violations.
 - 18 directed patrols conducted
 - 16 motor vehicle stops
 - 7 verbal warnings
 - 9 summonses issued
- **Leroy and Glenview Avenues:** Ongoing monitoring for stop sign compliance.

License Plate Reader (Tag Reader) Activity

- **Reads:** 611,000 plates scanned in May (up from 575,000 in April)
- **Vehicle Searches Related to Criminal Activity:** 102 (up from 22)
- **Summonses from Reader Hits:** 28 (from 20 reader hits; up from 11)
- **Traffic Stops from Reader Hits:** 27 (up from April totals)

Residents' Comments

A resident raised concerns about road repairs on Sequoia Drive following construction, which was identified as a South Jersey Gas project that will be addressed after construction is completed. The council clarified the process of professional fees and escrow accounts for construction projects in the town.

A resident expressed concerns about a neighbor's shed placement, citing safety issues for their autistic child and requesting a review of the relevant ordinance. The council offered to mediate the dispute and suggested having the town planner review zoning ordinances for potential improvements.

A representative from Boy Scout Troop 48 proposed an Adopt-a-Road program as a civic responsibility and fundraising opportunity for the troop. The council expressed support for the idea and discussed potential implementation, including business sponsorships and appropriate road selection. The meeting concluded with the council agreeing to work on developing the Adopt-a-Road program outside of the formal council session.
