- The Department of Public Works is working from a temporary trailer facility while awaiting permanent housing solutions.
- Ongoing infrastructure projects include leaf collection through December and planned road work for Ridgewood, Harker and other streets scheduled for spring.

WATER & SEWER Water and Sewer Monthly Report October 2025

Utilities and operations

- Water department completed 12 service orders, 91 mark-outs, monthly maintenance at water plants, and replaced 9 meters.
- Sewer department performed routine maintenance on 10 pump stations and emergency backup generators, while working on stormwater compliance reports.

- ➤ Police department handled 3,503 calls for service, issued 128 summonses, made 20 arrests, and responded to 29 motor vehicle crashes in October
- Multiple direct patrols were conducted for speeding complaints, with speed monitoring data showing favorable results - for example, on Washington Avenue 8,145 vehicles averaged 18-27 mp
